IMPORTANT: Please remember to include along with your form DS-230 a passport sized photo of the child. The photograph should be printed on glossy photo paper. The adoptee should be shown in full frontal view, with full head, from top of hair to bottom of chin. [A glossy photocopy of the passport sized photo you received of the child along with your referral documents is typically sufficient. Please write the child's name on the back of the photo. Please also paperclip the photo to your form – do not staple.](#)

Please read the instructions carefully prior to completing the form. If one spouse is traveling, please ensure that the information for petitioner 39 & 44 are listed as the spouse traveling to China.

1. Adopted Child's Chinese Name: Last, First Middle (please place both the first and middle names in the first name blank, separated, both names capitalized)
